Explanatory Statement (Pursuant to section 102 of the Companies Act, 2013)

As required under section 102 of the Companies Act, 2013 (Act) and Para 1.2.5. of SS-2 (Secretarial Standards of General Meeting), the following explanatory statement sets out material facts relating to the special business item mentioned under the accompanying Notice:

Item No 1:

The Shareholders agreement dated 20th August 2020 entered into between Ramky Enviro Engineers Limited (the Holding Company), Metropolis Investment Holdings Pte. Ltd, Alla Ayodhya Rami Reddy, Oxford Ayyappa Consulting Service (India) Private Limited, and the persons identified in Schedule I to the Shareholder's Agreement (hereinafter referred to as 'SHA') has been amended on 4th February 2021. To incorporate the relevant provisions of the amended Shareholder's Agreement into Articles of Association of Subsidiary Company, the Company needs to amend its existing Articles of Association.

The Board of Directors in their meeting held on 14th May, 2021 has recommended to amend the existing Articles of Association of the Company in line with those of Holding Company. Draft copy of the revised Articles of Association is provided as an annexure to this notice.

Pursuant to provisions of Section 14 of Companies Act, 2013, amendment of Articles of Association requires the approval of the Shareholders by way of Special Resolution. Accordingly, the abovementioned matter as recommended by the Board has been placed before the Shareholders for approval.
