Grant of Authorization under the provisions of the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016.

Mouza- Purba Srikrishnapur, P.S.; Sutahata, Dist; Purba Medinipur, Pin: 721635</u> is hereby granted an authorisation for generation, collection, reception, storage, transport, rouse, receycling, recevery, pre-processing, eo-processing, utilisation, treatment, disposal, or any other use of hazardous or other wastes or both on the premises located at J.L. No. 103 & 104, Mouza- Purba Srikrishnapur, P.S.; Sutahata, Dist; Purba Medinipur, Pin: 721635.

Details of Authorisation:

A. The authorization if valid for handling the following quantities of hazardous waste:

(2) The authorization is subject to the following general and specific conditions:

A. General conditions of authorization:

- 1. The authorised person shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
- 2. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the State Pollution Control Board.
- 3. The person authorised shall not rent, lend, sell, transfer or otherwise transport the hazardous and other wastes except what is permitted through this authorisation.
- 4. Any unauthorised change in personnel, equipment or working conditions as mentioned in the application by the person authorised shall constitute a breach of his authorisation.
- 5. The person authorised shall implement Emergency Response Procedure (ERP) for which this authorisation is being granted considering all site specific possible scenarios such as spillages, leakages, fire etc. and their possible impacts and also carry out mock drill in this regard at regular interval of time;
- o. The person authorised shall comply with the provisions outlined in the Central Pollution Control Board guidelines on "Implementing Liabilities for Environmental Damages due to Handling and Disposal of Hazardous Waste and Penalty"
- It is the duty of the authorised person to take prior permission of the State Pollution Control Board to close down the facility.
- 8. The imported hazardous and other wastes shall be fully insured for transit as well as for any accidental occurrence and its clean-up operation
- The record of consumption and fate of the imported hazardous and other wastes shall be maintained.
- 10. The hazardous and other waste which gets generated during recycling or reuse or recovery or pre-processing or utilisation of imported hazardous or other wastes shall be treated and disposed of as per specific conditions of authorisation.
- 11. The importer or exporter shall bear the cost of import or export and mitigation of damages if any.
- 12. An application for the renewal of an authorisation shall be three months before the expiry of such authorisation.
- Any other conditions for compliance as per the Guidelines issued by the Ministry of Environment, Forest and Climate Change or Central Pollution Control Board from time to time.
- Annual return shall be filed by June 30th every year for the period ending 31st March of that year.
- B. Specific conditions:
- 1. The unit shall store the hazardous wastes (category wise separately) under shade in an environment friendly safe manner within the premises at designated places and the unit shall not store hazardous waste on site for more than 90 days.
- 2. Incineration ash (37.2) and exhaust air or gas cleaning residue shall be landfilled in secured onsite landfill.
- 3. Waste or residues containing oil (5.2), spent carbon or filter medium (36.2) shall be incinerated in existing incinerator.
- 4. Scrubber sludge (37.1) shall be disposed through their own disposal facility following guidelines issued by CPCB time to time.
- 5. Used oil (5.1) and contaminated containers/drums/barrels (33.1) shall be sold through manifest system (Form 10) to the authorized recyclers having valid authorization of the State Pollution Control Board. During each sale, original Pass-book issued by SPCB to the authorized recyclers shall be endorsed mentioning the quantity and copy of the same shall be kept as record. If not fit for recycling shall be incinerated onsite in existing incinerator.
- 6. The unit shall submit copies of Form 10 to the State Board on a regular basis.

 Transport of hazardous and other waste shall be in accordance with the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016, guidelines issued by the Central Pollution Control Board (CPCB) and rules made under the Motor Vehicles Act, 1988. The responsibility of safe transport shall be either of the sender or the receiver whosoever arranges the transport and this responsibility shall be clearly indicated in the Manifest.

- 8. Hazardous waste landfill and incinerator to be operated and maintained as per CPCB guidelines.
- 9. CEMS data shall be transmitted to CPCB and the State Board.
- 10. Records of hazardous waste generation, storage and disposal shall be maintained properly and shall be available to the inspecting officials of the State Board during inspection.
- 11. The unit shall update regularly the environmental information in Display Boards as per the order of the Hon'ble Supreme Court dated. 14.10.2003 in W.P.(C) NO.657 of 1995.
- 12. All other conditions of Consent to Operate issued vide memo no.01/2S (CON)-2316/2008 (pt-I) dated 28.01.2019 shall be strictly followed.
